Richard responded that we are looking to purchase a system to implement telephone calls or texts. He noted that the state requires notification to affected customers, and that the Town notifies local news and radio stations in addition to Facebook.

The sewer line projects for 19E near Biggerstaff Road and Locust Street are close to the bidding stage. There has been no update on the grant applications for police and public works vehicles.

The damage at Brad Ragan Park from the November freeze is covered by insurance and will be repaired soon.

Officer Kelly Johnson noted that the drug dog is doing well. He will be going to Kentucky in March for training, He has a sponsor for the training, and is rooming with attendees from Yancey County. Food and gas will be the only town expenses.

# RESOLUTION OF THE TOWN OF SPRUCE PINE, NORTH CAROLINA

**WHEREAS**, the 1907 Charter of the Town of Spruce Pine measures the Town's area by measuring from the railroad depot; and

WHEREAS, the Toe River runs through the middle of Spruce Pine, providing water for our citizens' consumption, recreation, and livelihoods; and

WHEREAS, our pedestrian-only bridge spans the Toe River and railroad tracks, granting access to our heavily-used Riverside Park and Mayland Community College's up-and-coming Pinebridge facilities from our primary downtown district; and

WHEREAS, the bridge, built in 1940, is in need of repairs so that it may remain a vital literal and figurative link between commerce and recreation, and between bustling past and evolving future.

**NOW, THEREFORE, IT IS HEREBY RESOLVED,** that the Town Council of Spruce Pine supports the Spruce Pine Main Street request for \$500,000 in legislative contingency funds from the North Carolina House of Representatives and Senate to be applied to the bridge project.
