

TOWN OF SPRUCE PINE
LEAF, BRUSH, YARD WASTE, JUNK & WHITE GOODS PICKUP

Residents should call the Town Hall at 765-3000 in order to schedule pickup of leaves and brush.

Section 1. Leaf Pickup

- (a) Keep sticks and rocks out of the pile. Do NOT put leaves in bags.
- (b) Leaves need to be raked to the edge of the road, not into the street or onto the sidewalk. Leaf pickup is for leaves only. Do not mix other debris such as trash, limbs, brush, rocks, flowers, roots or garbage in the leaf pile.
- (c) DO NOT ALLOW CHILDREN OR ANIMALS TO PLAY IN THE LEAF PILE.

Section 2. Tree Trimmings and Brush Placement


- (a) Limb pickup is year round.
- (b) Place brush and tree trimmings at the edge of the street with all of the butts turned toward the street and stacked neatly into a pile and not scattered. Keep other debris out of the brush such as trash, leaves, rocks and metal. MAKE SURE NO PETS ARE IN THE BRUSH PILE.
- (c) No limbs or trimmings should exceed six (6) inches in diameter or six (6) feet in length.
- (d) Limbs and trimmings should be placed as not to interfere or obstruct the flow of traffic.

Section 3. No Collection of Contracted Work

Tree and shrubbery branches, nor limbs, trimmings and yard waste cut by landscapers, tree service contractors, commercial workmen, day laborers or resulting from land being cleared by a contractor shall not be collected by the Town. This applies to large acreage tracts or vacant lots being developed within the Town as well as residential property. IT IS THE RESPONSIBILITY OF THE HOMEOWNER/OCCUPANT AND CONTRACTOR TO REMOVE SAID TRIMMINGS.

Section 4. Prohibited Collections

- (a) Heavy bulk accumulations such as brick, broken concrete, lumber, ashes, dirt, plaster, sand, gravel, automobile frames and parts, and dead trees shall not be collected by the Town but disposed of by the owner or person controlling the premises.
- (b) No waste building materials or lot clearings shall be collected from houses or other structures under construction or recently completed.
- (c) No collection shall be made from vacant lots, nor shall any large rocks, tree trunks or stumps be collected by the Town.
- (d) No carpet or building materials from home renovation shall be collected.



Section 6. Junk and White Goods

- (a) Junk and white goods pickup will be provided year-round on an as called basis. Residents are to call the Town Office and let the staff know what items need to be picked up so a pickup date can be arranged.
- (b) Junk and white goods items are to be placed at the curb or the edge of the street.
- (c) All doors on white goods are to be removed and/or secured prior to being placed at the curb.

Section 7. Hazardous Materials

Listed below is a partial list of hazardous materials that will not be picked up by the Town.

1. Paints
2. Flammable Liquids
3. Driveway Sealant
4. Acid
5. Herbicides and/or Pesticides
6. Asbestos
7. Freon
