Minutes Spruce Pine Town Council July 8, 2024 5:30 PM

A meeting of the Town Council was held on July 8, 2024. Present were Mayor Phillip Hise and Council Members Rocky Buchanan, Larry McKinney, Jackie Rensink, and Wayne Peight. Staff in attendance included Michael Wood, Kasey Cook, Travis Phillips, Darlene Butler and Brooke Peterson. Others attended, including Chad Donnahoo, Donnie Staton, Jeff Harding, and Gina Phillips.

CALL TO ORDER

Mayor Phillip Hise called the regular meeting to order at 5:30 PM. Rocky Buchanan gave the invocation. Wayne Peight led the Pledge of Allegiance.

APPROVAL OF AGENDA

Larry McKinney moved to approve the agenda with the tabling of selecting a new on-call engineer. Jackie Rensink seconded the motion, which carried unanimously.

APPROVAL OF MINUTES

Rocky Buchanan moved to approve the minutes of the June 24, 2024 Town Council Meeting. Larry McKinney seconded the motion, which carried unanimously.

Jackie Rensink moved to approve the minutes of the June 24, 2024 Closed Session Meeting. Wayne Peight seconded the motion, which carried unanimously.

CLOSED SESSION

Mayor Hise moved to enter into closed session, citing NCGS 143-318.11 (a) (3) — To consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege. Kasey Cook, Michael Wood, Travis Phillips, Donnie Staton, Jeff Harding, and Gina Phillips departed the board room.

RETURN TO OPEN SESSION

Council Member Larry McKinney moved to resume open session. No action was taken by the council during closed session. Kasey Cook, Michael Wood, Travis Phillips, Donnie Staton, Jeff Harding, and Gina Phillips returned to the board room.

PUBLIC COMMENT

❖ Gina Phillips presented the Hilloween event coming up on October 26, 2024 from 2 PM to 10 PM on Locust Ave. This event is a total of 5 days all over Mitchell County. Gina is requesting the street closure of Locust Avenue, just like last year. She noted the businesses downtown were very busy last year and she is hoping for the same economic impact this year. Gina also noted there is a very well-known band that will be playing this year and she will be able to announce that on September 1, 2024.

- ✓ Wayne Peight made a motion to adopt Ordinance #24-3. Chapter 13 Noise. Jackie Rensink seconded the motion, which carried unanimously. Said Ordinance is incorporated by reference and attached to these minutes.
- ✓ Larry McKinney made a motion to adopt Ordinance #24-2. Chapter 14 Nuisances. Rocky Buchanan seconded the motion, which carried unanimously. Said Ordinance is incorporated by reference and attached to these minutes.

✓ Larry McKinney made a motion to approve the Special Event Permit Application for Hilloween for Gina Phillips on October 26, 2024, pending insurance policy. Jackie Rensink seconded the motion, which carried unanimously.

DEPARTMENT UPDATES

Finance

• Finance Officer Crystal Young was not in attendance.

Water and Sewer

- Project Manager Donnie Staton with Veolia gave his report for the month of June. Said report is incorporated by reference and attached to these minutes.
- Donnie noted the new McHone water pump has been delivered and should be installed this week.
- He also noted that the Carter's Ridge new sewer pump should be here soon.

Public Works

- Public Works Director Travis Phillips presented a Work Order Summary Report for his department. Said report is incorporated by reference and attached to these minutes.
- Travis noted the brush truck will be out of commission for a few weeks, due to needed repairs being completed.
- He also noted that the new equipment trailer will be here this week.
- The council, Travis Phillips, and Darlene Butler discussed employment opportunities between this department and Park and Rec. An employee will be retiring this year; therefore, a position will be available in Public Works. However, that employee is an asset to the department so a part-time position is being proposed. The council has approved a full-time position between Public Works and Parks and Rec. for the 2024/2025 budget year.

Main Street

- Main Street Director Spencer Bost was not in attendance.
- The council discussed holding a town wide yard sale like Bakersville for the upcoming Labor Day holiday weekend. The council also discussed speaking with town merchants about this event. Darlene Butler noted that the Main Street Board is meeting this week.

Parks and Rec

- Parks and Rec Director Michael Wood presented his June report for Parks and Rec, which is incorporated by reference and attached to these minutes.
- Michael noted that all parks have been very busy and pool revenue has increased this year. He noted the
 park improvements and the new slide at the pool have contributed to the amount of people utilizing the
 parks. He stated an increase in shelter reservations too.
- The grand opening for the new Riverbend Park is set for Monday-July 29 at 2 PM. Refreshments will be served.

Police Department

- Police Chief Kasey Cook updated the Council on the police department for the month of June, presenting a
 log with a total of 420 calls logged through Mitchell County Communications. Said log is incorporated by
 reference and attached to these minutes.
- Chief Cook noted the department has been short staffed, due to two detectives attending instructor certification classes. Both detectives passed and are now certified.
- He also noted that both detectives are searching for a vehicle for the new 2024/2025 budget and will be traveling this week to look at those.
- Chief Cook stated that the parks are very busy this time of year and his officers will be present.
- Chief Cook and Darlene Butler will be meeting with a firm to review and update policies on Thursday this
 week.

MANAGER'S UPDATE

- > Town Manager Darlene Butler stated County Manager, Allen Cook is meeting with Duke Energy tomorrow at the EDC Office at 1 PM.
- > Darlene discussed meeting with a firm updating the policies and procedures this week.
- > She noted that fireworks were great and people in the area were able to see several shows on different days at different locations. Next year a park staff member will be present at Riverside Park to help direct people.
- Darlene described the groundhog issues that are occurring downtown. She has spoken with the NC Wildlife Commission and how to address the issues. The council discussed there are a few different resolution options. Darlene will be contacting an exterminator with a special trapping permit to assess the groundhog problems. The intersection at Summit Avenue is in crucial need of removing the groundhogs due to infrastructure issues with the concrete drain.
- Darlene explained the Yancey County Library letter regarding the intent to withdraw with effective date of June 30, 2025 and the potential impact on Bakersville, Spruce Pine, and Avery County libraries.
- The July 22, 2024 the Town Council meeting will be cancelled.
- Monday July 15 from 10-12 the EDC is sponsoring an event at the Small Business Center regarding the housing crisis.
- Darlene noticed an event on social media from Mitchell County Schools regarding a public forum for selling of the Deyton and Harris buildings that will be held on Thursday July 11 at 6 PM in the Harris auditorium.
- Darlene spoke with Pat Dale regarding the property at the water shed and he was still interested in giving that back to the town. She also discussed the easements to extend the walking path to and from Riverbend Park to Riverside Park. The council discussed the liabilities involved with the property at the water shed and easement possibilities.

MAYOR/COUNCIL COMMENTS

Larry McKinney expressed he wanted to get estimates for someone to mow the riverbank at Riverside Park. He also had questions regarding the old bathrooms. The council discussed cleaning up the mulch and removing the fencing will be completed in house, but Miller Construction will be removing the equipment.

ADJOURNMENT

With no further business, the meeting was adjourned by motion of Larry McKinney at 7:14 PM.

WHEREAS, on or about August 10, 1981, the Council adopted an ordinance amended Section 13-2 (the 1981 Ordinance);

WHEREAS, the Council desires to update the Code to comprehensively update and address noises; and

WHEREAS, the proposed Ordinance #24-3, attached hereto as Exhibit A, was presented to the Council for first reading at its June 24, 2024 meeting and was published on the Town's website thereafter allowing inspection by the public.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL the following:

- 1. That the current Chapter 13 of the Code and the 1981 Ordinance are hereby repealed;
- 2. That pursuant to Section 1-8(c) of the Code, Chapter 13 is hereby amended by adding the new Chapter 13 contained in Exhibit A hereto; and
- 3. That the new Chapter 13 shall be effective immediately, but enforcement thereof shall be implemented no earlier than twenty (20) days from the effective date to allow the public the opportunity to voluntarily comply with the new Chapter 13 and the requirements therein.

NOW COMES the Town of Spruce Pine ("Town"), on this 8th day of July, at a duly called meeting of its Council with a quorum established, and hereby considers this Resolution to Adopt Ordinance #24-1 – Revisions to Chapter 12 of the Town of Spruce Pine Code Updating Abandoned, Nuisance and Junked Vehicles.

WHEREAS, on or about August 18, 1975, the Council adopted the Town of Spruce Pine Code ("Code") and Chapter 12 – Motor Vehicles, Article VI – Removal of Abandoned and Junked Vehicles and Sections 12-71 through 12-81 therein;

WHEREAS, on or about July 13, 2009, the Council adopted an ordinance to amend the Code by adding Article XIV and Section 140A thereof (the "2009 Ordinance"). The 2009 Ordinance revised and updated the Town of Spruce Pine Code addressing junked vehicles;

WHEREAS, the Council desires to update the Code to comprehensively address abandoned, nuisance and junked vehicles with respect to N.C.G.S. §§ 160A-303 and -303.2; and

WHEREAS, the proposed Ordinance #24-1, attached hereto as Exhibit A, was presented to the Council for first reading at its June 24, 2024 meeting and was published on the Town's website thereafter allowing inspection by the public.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL the following:

- 1. That the current Chapter 12, Article VI of the Code and the 2009 Ordinance are hereby repealed;
- 2. That pursuant to Section 1-8(c) of the Code, Chapter 12 is hereby amended by adding the new Article VI contained in Exhibit A hereto; and
- 3. That the new Article VI shall be effective immediately, but enforcement thereof shall be implemented no earlier than twenty (20) days from the effective date to allow the public the opportunity to voluntarily comply with the new Article VI and the requirements therein.

- 1. That the current Chapter 14 of the Code is hereby repealed;
- 2. That pursuant to Section 1-8(c) of the Code, Chapter 14 is hereby amended by adding the new Chapter 14 contained in Exhibit A hereto; and
- 3. That the new Chapter 14 shall be effective immediately, but enforcement thereof shall be implemented no earlier than twenty (20) days from the effective date to allow the public the opportunity to voluntarily comply with the new Chapter 14 and the requirements therein.


